RE: Focus 2015 Listening Sessions

As part of UW-Stout's open, participatory planning process, all faculty, staff and students are invited to the listening sessions held each fall to discuss the fall 2009 University Priorities and to provide input on future priorities to achieve FOCUS 2015. We would like to encourage you to attend one of these sessions.

During the listening sessions, you will have the opportunity to:

- hear about the FOCUS 2015 goals,
- provide feedback on the fall 2009 University Priorities already underway, and
- provide input on ideas for future University Priorities.

Last year, nearly 400 faculty, staff and students attended the listening sessions.

Listening Session History

UW-Stout develops new "FOCUS" goal statements every five years. The first of these goals was FOCUS 2010. Since implementing FOCUS 2010, UW-Stout identified, implemented and funded 21 University Priorities. Prior to FOCUS 2010, over 45 priorities were identified, implemented and funded.

Major initiatives have begun as a result of your input at these listening sessions:

- implementing customized instruction, which is now available in 24 programs,
- achieving polytechnic designation,
- increasing enrollment from 7,708 to approximately 8,600 students in fall 2009,
- increasing scholarship awards from \$1,538,012 to \$2,252,795,
- increasing the number of distance education courses from 184 to 278,
- establishing the Curricular Incubation Center, and
- rolling out the e-Scholar program.



Background for FOCUS 2015

In summer 2008, UW-Stout held a Stakeholder Visioning Session to kick off the FOCUS 2015 planning process. The Visioning Session was attended by 85 participants, including legislators, a member of the UW System Board of Regents, as well as leaders from business, the Menomonie community, education, UW System, UW-Stout, students and the Stout Foundation. In small groups, the listening session participants identified big ideas that UW-Stout should be thinking about in the next five to eight years. All of their ideas were typed up, and themes were identified.

During 2009-10, two committees were formed:

- The first committee utilized a participatory process to complete a review and update of UW-Stout's Mission, Vision and Values, and
- The second committee utilized the feedback from the Visioning Session and Listening Sessions to develop four FOCUS 2015 goal statements.

In summer 2009, the strategic planning group developed four University Priorities to support these FOCUS 2015 goal statements. Additional University Priorities to achieve FOCUS 2015 will continue to be identified over the next several years.
