# **SECTION 3: HAZARDS IDENTIFICATION**

## 3.1 EMERGENCY OVERVIEW

## 3.2 POTENTIAL HEALTH EFFECTS

# **SECTION 4: FIRST AID MEASURES**

# SECTION 6: ACCIDENTAL RELEASE MEASURES

Accidental Release Measures: Refer to other sections of this MSDS for information regarding physical and health hazards, respiratory protection, ventilation, and personal protective equipment. Ventilate the area with fresh air. Read and follow safety precautions on the solvent label and MSDS. Collect the resulting residue containing solution. Place in a metal container approved for transportation by appropriate authorities. Seal the container. Dispose of collected material as soon as possible.

# **SECTION 7: HANDLING AND STORAGE**

### 7.1 HANDLING
